- ☐ **Current, valid government issued photo ID**  
Such as a [Driver's License](#), [State ID card](#), [Passport](#), [Armed Forces ID card](#).
  - ☐ **Verification of Income**  
Please bring [paystubs](#) (within 30 days with year to date income) and [most recent W-2](#).  
**If self employed:** [two years of tax returns](#).
  - ☐ **Proof of insurance with auto loan (if applicable)**

## Non-Citizen

- ☐ **Current, valid government issued photo ID**  
Such as a [Driver's License](#), [State ID card](#), [Passport](#), [Armed Forces ID card](#) or [Matricula Consular ID](#).
  - ☐ **Verification of Income**  
Please bring [paystubs](#) (within 30 days with year to date income) and [most recent W-2](#).  
**If self employed:** [two years of tax returns](#).
  - ☐ **Copy of ITIN card/letter or working SSN card**
  - ☐ **Proof of insurance with auto loan (if applicable)**

## Minor

- ☐ **Current, valid government issued photo ID**  
Such as a **Birth Certificate**, **State Issued ID** or **Passport**.  
School IDs are **NOT** a valid form of identification.
  - ☐ **Copy of ITIN card/letter or Social Security Card**
  - ☐ **Proof of Current Address**  
Such as a **Utility Bill (excludes cellphone)**, **lease agreement**, **recent paystub** or **mortgage statement**.
  - ☐ **Must be accompanied by a legal guardian to be added as joint owner at time of account opening. Legal guardian must have documents listed under **US Citizen/Non-Citizen Section**.**
